The Carl Junction City Council met in regular session on Tuesday October 1, 2024 at 7:00 PM at City Hall. Hollie LaVigne motioned to approve the agenda as amended. LaDonna Allen seconded. All in favor. No opposed with two absent. Hollie LaVigne asked about the expenditures to the Mary Mitchell Estate, S&S Computers, and Steve Thomas. LaDonna Allen motioned to approve the consent agenda. Walter Hayes seconded. All in favor. No opposed with two absent.

# DISCUSSION OF GYM RENTAL FEES

Steve Lawver said there was a letter included in the packet from Ken Wickstrom explaining what he wants to do and a proposed agreement for non-profit organizations outside the city limits. Hollie LaVigne asked who the non-profits are that reserve the gym and then don't show up. Steve Lawver said there is a homeschool association and a volleyball team that reserve it also. Hollie LaVigne said she would be in favor of charging out of town non-profit organizations and LaDonna Allen agreed. There was a consensus among the council that the fees could be charged.

# **ORDINANCES**

LaDonna Allen motioned to put "AN ORDINANCE APPROVING A SERVICE AGREEMENT BETWEEN THE CITY OF CARL JUNCTION, MISSOURI AND MID CENTRAL CONTRACTORS, LLC, TO BE A PREFERRED SERVICE PROVIDER FOR THE IMPLEMENTATION OF NEW PROJECTS, UPGRADES AND MAINTENANCE TO MEET THE NEEDS OF THE CITY OF CARL JUNCTION, MISSOURI, INCLUDING, BUT NOT LIMITED TO, THE POLICE DEPARTMENT, COMMUNITY CENTER, CITY PARKS AND PUBLIC WORKS, FOR THE SUMS SET FORTH IN THE AGREEMENT; AND AUTHORIZING THE MAYOR TO EXECUTE SAID SERVICE AGREEMENT FOR AND ON BEHALF OF THE CITY OF CARL JUNCTION, MISSOURI" on second reading by title only. Rick Flinn seconded. All in favor. No opposed with two absent.

Discussion: Steve Lawver said he did go to Patti at Mo Parks and asked if there was an appeal process to pare down the land and she said there was not anything like that. Hollie LaVigne asked about the details and Steve said if at any point we would need to sell part of the property we would have to get approval from the State of Missouri. Steve Lawver said this is what happens anytime someone uses LWCF grant money.

Hollie LaVigne motioned to put it on final passage. LaDonna Allen seconded. All in favor. No opposed with two absent.

LaVigne-yes, McAfee-absent, Flinn-yes, Spencer-absent, Allen-yes, Pyle-no, Hayes-yes, Wofford-yes. Motion on Ordinance #24-31 was approved by roll call vote, signed by the Mayor Pro Tem, attested by the City Clerk and made a part of the permanent records of the City of Carl Junction.

LaDonna Allen suggested we get an estimate to see what the cost would be if we paid for the project ourselves, rather than accepting grant money.

Hollie LaVigne asked when the work would begin for the lighting at Memorial Park and Jay Morton said it would probably start next week.

Public Works report - No discussion.

Police Dept. report - Chief McCall said the car & motorcycle show is October 12 to raise money for Shop with a Cop.
