The Carl Junction City Council met in regular session on Tuesday May 4, 2021 at 7:00 PM at City Hall. Mayor Mark Powers called the meeting to order with the following present: Jim Gozia, Bob McAfee, Rick Flinn, Roger Spencer, Ladonna Allen, Mike Burns, Mark Satterlee and Gary Stubblefield. Also present were City Administrator Steve Lawver, City Attorney Mike Talley, City Clerk Maribeth Matney, Deputy City Clerk Alaina Wright and City Administrator Assistant Crystal Winkfield.

AGENDA

Roger Spencer motioned to approve the agenda as presented. Mark Satterlee seconded. All in favor. No opposed. LaDonna Allen motioned to approve the consent agenda. Roger Spencer seconded. All in favor. No opposed.

SWEAR IN MARK SATTERLEE

Mark Satterlee was sworn in by the city clerk.

ASSIGN COMMITTEE MEMBERS

Mayor Powers assigned committee members for the upcoming year.

SCHUBER MITCHELL HOMES DISCUSSING STORMWATER DETENTION IN COUNTRY CLUB PARK

Dan Mitchell with Schuber Mitchell Homes was present to ask that the board allow Schuber Mitchell to expand their detention pond into an unused area in Country Club Estates Park.

Roger Spencer asked how big the current pond is. Dan Mitchell said it is the size of two home lots and they want to add another 30 feet into the park on the east.

Mayor Powers asked what effect this would have on the plan to connect Anita Drive with Fir Road. Josh with Anderson Engineering was present and he said he and the city engineer do not recommend taking Anita Drive to Fir Road, especially if Fir Road will be widened.

LaDonna Allen asked what kind of precedent it sets to allow people to take city parks and turn them into detention ponds for plans that haven't been approved yet. She also asked if there are plans for a fence around the pond area and what kind of dollar amount investment they would be making in return for taking part of the park.

Mark Satterlee asked if these ponds are grass or rock. Dan Mitchell said most of them are grass. Mark then asked if there's a question of upkeep, is it possible to use rock rather than grass to keep maintenance low.

Rick Flinn asked if they would bring in extra dirt if they didn't dig up enough to raise up the soccer fields.

Mike Talley asked if the plans they are putting together will include the proposed changes to the soccer fields.
